Projects Recommended to Pursue Infrastructure Fund Assistance:

Danese PSD-Maplewood Improvements - (tabled application) 2022W-2225

Meredith Vance described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends Danese PSD pursue a \$1,000,000 DWTRF Principal Forgiveness Loan, a \$4,800,000 DWTRF Loan (1%, 40 yrs, 0.25% AF), a \$500,000 Fayette County Commission Grant, a \$1,000,000 WDA EEGF, and a \$500,000 IJDC Grant for an estimated project cost Of \$7,800,000.

Hancock County PSD – Newell System Replacement (cost and funding change) 2021S-1980 Wayne Morgan described the request.

The Technical Review and Funding Committee recommends Hancock County PSD pursue a \$700,000 CWSRF Principal Forgiveness Loan, a \$2,900,000 CWSRF Loan (0.5%, 40 yrs, 0.25% AF), a \$1,550,000 WDA EEGF, a \$50,000 District Contribution, a \$5,000,000 IJDC Distressed Utilities Grant, and a \$500,000 IJDC Grant for an estimated project cost of \$10,700,000.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Huntington, City of-WWTP Improvements I - (tabled application) 2022S-2245

Kathy Emery described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Huntington pursue a \$2,000,000 CWSRF Principal Forgiveness Loan, a \$1,400,000 CWSRF Green Emerging Contaminant Forgiveness Loan, \$500,000 CWSRF Green Efficiency Forgiveness Loan, a \$500,000 CWSRF Green Stormwater Forgiveness Loan, a \$500,000 CWSRF Green Water Efficiency Grant a \$7,600,000 WDA EEGF and a \$1,000,000 IJDC Grant and a 130,000,000 CWSRF Loan (0.25, 38 yrs., 0.25% AF) for and estimated project cost of \$143,500,000.

Masontown, Town of WWTP - (engineering fee variance) 2022S-2212

Kathy Emery described the request.

The Technical Review and Funding Committee recommends the Town of Masontown engineering fee variance request for total engineering fees be approved.

Wardensville, Town of -System Improvements (scope, cost, and funding change) 2020S - 1873 Wayne Morgan described the request and suggested it be tabled.

Webster County EDA-Bear and Big Run Ext. - (cost & funding change) 2020W-1913 Wayne Morgan described the request.

The Technical Review and Funding Committee recommends the Webster County EDA pursue a \$2,882,000 ARC Grant, a \$208,000 WV American Water Contribution, and a \$1,000,000 IJDC Grant for an estimated project cost of \$4,090,000.

Huntington, City of-3rd/5th Ave. Sewer Separation - (tabled application) 2022S-2244

Kathy Emery described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Huntington pursue a \$7,500,000 Huntington ARPA Contribution, a \$1,500,000 CWSRF Debt Forgiveness Loan, a \$500,000 CWSRF Green Stormwater Forgiveness Loan, and a \$500,000 CWSRF Green Energy Forgiveness Loan for an estimated project cost of \$10,000,000.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Logan Co. PSD - Holden Ext. 257 cust. (new application) 2022S-2174

Kathy Emery described the request, and it is technically feasible.

The Technical Review and Funding Committee recommend Logan County PSD pursue a \$6,000,000 AML Grant, a \$2,000,000 CWSRF Principal Forgiveness Loan, a \$2,870,000 CWSRF Loan (0.75%, 30 yrs, 0.25% AF), and a \$500,000 Logan County Commission Grant for an estimated project cost of \$11,370,000.

Marie Prezioso moved that the recommendation be approved, Kathy Emery seconded the motion. The motion passed.

Mannington, City of - Burt Hill Tank Replacement (new application) 2022W-2256

Meredith Vance described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Mannington pursue a \$385,000 WDAEEGF, a \$350,000 City ARPA funds, and a \$150,000 Marion County ARPA funds for an estimated project cost of \$885,000.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Parkersburg, City of - WTP Improvements - (new application) 2022W-2250

Meredith Vance described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Parkersburg pursue a \$12,630,000 DWTRF Emerging Contaminant Principal Forgiveness Loan.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Preston County No. 4 – Source of Supply (tabled application) 2022W-2228

Meredith Vance described the request, and it is technically feasible

The Technical Review and Funding Committee recommends Preston County PSD No. 4 pursue a \$2,491,393 US EDA Grant, a \$155,712 Preston County ARPA Grant, and a \$467,136 WDA EEGF for an estimated project cost of \$3,114,241.

Marie Prezioso moved that the recommendation be approved, Kathy Emery seconded the motion. The motion passed.

Wilderness PSD - System Improvements I (new application) 2022W-2253

Meredith Vance described the request, and it is technically feasible.

The Technical Review Committee recommends that the request of Wilderness PSD pursue a \$2,790,000 USDA Loan (1.87%, 40 yrs), a \$634,508 Nicholas County ARPA Grant and a \$608,164 WDA EEGF for an estimated project cost of \$4,032,672.

Marie Prezioso moved that the recommendation be approved, Erica Boggess seconded the motion. The motion passed.

Projects Requesting Infrastructure Fund Binding Commitment:

Putnam County Commission-Jim Ridge III (cost, funding & cont. binding com.) 2019W-1830 Wayne Morgan described the request.

The Technical Review and Funding Committee recommends the Putnam County Commission pursue a \$1,500,000 CDBG Grant, a \$765,000 WDA EEGF, a \$1,000,000 IJDC Grant, a \$288,000 Putnam County Commission Grant, and a \$312,000 WVAWC Contribution for an estimated project cost of \$3,865,000; and receive a \$1,000,000 IJDC Grant transferred from Loan Funds contingent upon receiving the \$765,000 WDA EEGF.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Projects Requesting Ancillary Project Expenditure:

Pennsboro, City of -ancillary expenditure (use of contingency) 2018W-1766

Wayne Morgan described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Pennsboro ancillary expenditure of \$300,635 from contingency funds request be approved contingent upon submitting an updated schedule B and appropriate documentation to proceed with construction of Deductive Alternate 1.

Marie Prezioso moved that the recommendation be approved, Erica Boggess seconded the motion. The motion passed.

Economic Development Assistance:

Hino Motors Manufacturing USA, Inc. (loan modification) 2017E-173

Joseph Brouse described the request.

IJDC approved a performance loan that required Hino to maintain 545 full time equivalent employees in Wood County, West Virginia, either at the Property or at the Property combined with its Williamstown, West Virginia facility. This shall include at least 250 full-time equivalent employees at the Property and that the full-time equivalent employees have a minimum average annual salary of \$45,760 per year, including paid benefits on the site by October 24, 2022. Hino currently has 364 jobs on site as COVID and COVID related supply chain issues have hindered the company from getting to their stated goal. The company reports that vehicle demand is robust and has committed to creating the balance of the jobs by October 24, 2024.

Joseph Brouse moved that the request to extend the performance period to October 24, 2024, for the Hino Motors Manufacturing Loan (2017E-173), be approved. Marie Prezioso seconded the motion. The motion passed.
